### Investors and Volunteers

The Tracy Development Corporation (TDC) was formed in October 2017 by a small group of individuals writing checks to this non-profit organization for the sole purpose of retention and creation of jobs, together with expanding the tax base of the community.

There is no personal gain. Should the organization terminate in the future, the remaining funds will be used for the good of the organizations goals within the community.

A board of volunteering directors govern and direct the organization to assist new and existing businesses. The TDC may become involved in land acquisition then reselling the property or placing a building on the property to sell or rent or improving the land and infrastructure for multiple development projects. TDC has no interest in owning or operating a business beyond leasing buildings.

For many years Tracy enjoyed a similar role from Tracy Enterprises (TE). They built and developed an industrial park on the east side of Tracy, constructing a "spec" building to rent and sell. This was a prosperous and successful project by the creation of jobs and an enlarged tax base. One of the buildings has had two other owners since Homera leased the building in the early '70s. Their reach was felt in several other building projects that brought new companies to Tracy with an enlarged economic vitality. TDC's mission remains the same. Realistically this will not be an overnight success – but long-term, this concentrated effort along with financial investments and a devoted board, more good things can occur.

In a short time, since TDC's inception, several projects have been initiated. A competitive broadband environment for expanded services, an acquisition of decaying properties with site improvements underway for prospective new enterprises, plus assisting several businesses situated for location and growth in Tracy.
